#### CALL TO ORDER

The meeting was called to order. The WDB had a quorum of 33 members present.

## APPROVAL OF MINUTES

Joe Filippone made a motion seconded by Joe Sikes to approve the minutes of the February 13, 2018, Workforce Development Board Meeting. Motion carried.

# INTRODUCTION OF GUEST

Chair Jordan introduced Antonia Frawley with Coastal Pines Technical College, Barbara Ault with Legacy Link, Robin Cone with Georgia Vocational Rehabilitation, April McDuffie with Wiregrass Technical College, Deirdra Miller with Wiregrass Technical College, and Bobby Smith with MidCoast Aviation Services.

## **GUEST SPEAKER**

Alexis Eason introduced Bobby Smith with MidCoast Aviation Services. Mr. Smith thanked the WDB for inviting him to speak. He stated that MidCoast Aviation Services is a flight training school located in Reidsville, Georgia. The school is PART 141 Certified and Veterans Administration approved for private pilot, instrument pilot, commercial pilot, certified instrument instructor and additional category courses. MidCoast Aviation Services was created because the military veterans stationed primarily at Ft. Stewart and Hunter Army Airfield in Savannah did not have any local flight training opportunities. Mr. Smith stated that there are no flight schools within 200 miles of the area certified or able to provide flight training for veterans. MidCoast Aviation Services was formed primarily to provide training for active military veterans while still in the military. Once they complete the required training, they can make a smooth transition from military to civilian employment in the field of aviation without any lapse in employment. He thanked WIOA for stepping in to help these Veterans attend this school. He stated that without WIOA, they would not be able to attend because the Veterans Administration would not cover the full cost.

## **DIRECTOR'S REPORT**

Keith stated that the process of WIOA transitioning from Economic Development to the Technical College System of Georgia was continuing to develop. He stated that there had been no changes in operations so far, but changes to policies and regulations would be coming after the transition. Keith stated that he attended the state board meeting and the new state board members were introduced. He stated that the transition would occur July 1, 2018, and more information regarding the transition would be available at the August meeting. He stated that Rapid Response would move back under the Department of Labor.

#### ATTENDANCE COMMITTEE

Wayne Hall thanked everyone for attending, and 33 members were present. He encouraged the WDB members to make sure they are signed up to serve on a committee and for all new members to attend the new member orientation held at the WDB Retreat.

## **BUDGET AND EVALUATION COMMITTEE**

Dr. Paul Scott referred everyone to the Heart of Georgia Altamaha WIOA Expenditures sheet. He stated that this is the layout for the money spent, and everything is up to date and on track.

Dr. Paul Scott stated that the Budget and Evaluation Committee reviewed and discussed updates to two policies; the Self-Sufficiency and Suitability Guidelines, and the Supportive Services Policy. Dr. Paul Scott stated that the Budget and Evaluation Committee recommends that these two policies be updated to align with the state's policies. The wording for the updates was taken directly from the state's manual. Billy Trapnell seconded. Motion carried.

# **DISABILITY COMMITTEE**

Stephanie Woods stated that the Resource Manual would be available at the next WDB retreat, and each county will break into groups to make sure all information is up to date.

## ONE-STOP COMMITTEE

Billy Trapnell referred the WDB members to the Customer Service Comment Cards Report and stated that everything looked good. He referred the WDB to the Customer Count Report. This report compares numbers from month to month, and the numbers are less this year compared to last year.

#### PLAN AND PROGRAM REVIEW

Tim Herrington referred the WDB members to the Region 9, Area 16- PY17 Performance Report. He stated that this report is received once a year and tracks the performance for the year. All performance goals were met and exceeded for the year.

Tim referred the WDB members to the Customer Count Report. He requested that the WDB members look at the numbers served in their county. He stated that the report has two sections; training services, and business services. The total number of training services customers being served is 1,387, and the total number of business services customers being served is 41,259.
